She has produced technical regulation products and technical guidelines in the fields of medicines, biological products, traditional medicines, health supplements and cosmetics, both in Indonesia and ASEAN when she has been as Director of Product Evaluation at National Agency of Drug and Food Control R.I. (2001-2012), General Director of Pharmaceuticals and Medical Devices at Ministry of Health R.I. (2012-2018). During her career, she has achievement on national program on Self-Reliance of Pharma and Medical Devices Industries and technical regulatory on National Formulary, electronic catalog of medicines, quality system of medicines and medical devices, as well as good practices on clinical trial of medicines and medical devices.
